**Mr. Nabil Adel KASSAR** holds a Bachelor's degree in Law from the Saint Joseph University of Beirut and a DEUG (Diploma of General University Studies) in Law from Panthéon-Assas University (Paris). With over 30 years of experience within the Fransabank Group, he has built a distinguished career marked by senior leadership, strategic management, and governance responsibilities.

**Mr. KASSAR** began his career at Fransabank S.A.L. in 1994, where he successively held several key positions, including Deputy Chief Executive Officer (2006–2009 , 2022–2025) and Chief Executive Officer (2015–2022). Following his many years of dedicated service in executive roles, he was appointed Chairman of Fransabank S.A.L. in June 2025.

In addition to his role at Fransabank, **Mr. KASSAR** serves as Chairman of Fransa Land S.A.L., a company specialized in real estate and development, and Chairman of A.A. KASSAR S.A.L. (Holding), a trading and investment company engaged in commercial and financial activities.

He previously served as Chairman and Chief Executive Officer of Fransa Invest Bank S.A.L., the investment arm of Fransabank S.A.L., and as Vice Chairman of BLC Bank S.A.L., where he contributed significantly to strategic development and financial management. Over the years, **Mr. KASSAR** has overseen key strategic areas including retail banking, digital transformation, information security, operations, and marketing and communications, while actively participating in multiple governance and risk management committees.

**Mr. KASSAR** also represents Fransabank S.A.L. on the Boards of Directors of several subsidiaries and affiliated companies within the Fransabank Group, including Fransabank France S.A. and Fransabank El Djazair S.P.A., where he serves as a Board Member, member of Credit Committee "A", and Chairman of the Investment Committee.
